

SERVICE CONTRACT

In consideration of the mutual covenants herein contained and, intending to be legally bound hereby, the Client and the Hair Stylist agree as follows:

TERMS AND CONDITIONS

PAYMENT FOR SERVICES RENDERED. In full consideration for all services rendered by the Hair Stylist at the event location, the Client agrees to make the following payments in US Dollars via cash, personal check, cashier’s check, or money order payable to the Hair Stylist:

CANCELLATION. In the event the Client wishes to cancel this Contract less than one month prior (30 days or less) to the scheduled event date, the Client agrees to the forfeiture of the deposit made to the Hair Stylist. Upon the forfeiture of the Client's deposit, the Client will have no further liability to the Hair Artist hereunder. In the event the Client wishes to cancel this Contact more than one month prior (30 days or more) to the scheduled event date, the Hair Stylist shall refund any deposit made to secure their services within no more than 2 weeks (14 days or less). Any fees paid for services rendered by the Hair Stylist prior to the cancellation of this Contract are considered non-refundable. The cancellation of this Contact must be executed in writing and signed by both parties.

LIMITED LIABILITY. Any skin condition or allergies should be reported by the Client to the Hair Stylist prior to application and, if need be, a sample test may be performed to test for possible reaction. Client agrees to release the Hair Stylist, all employees, and agents from liability for any allergies or complications due to allergic reactions. The parties to this Contract specifically agree that, because any damages arising from or related to the provision of the services rendered under this Contract cannot be readily ascertained by any pecuniary standard, the damages shall be limited to an amount equal to the amount paid made pursuant to this Contract. Under no circumstances shall either party be liable to the other party or any other person or entity special damages, incidental damages, consequential damages, or exemplary or punitive damages.

ADDITIONAL SERVICE FEES. Fees are only applicable if agreed upon by both the Client and Hair Stylist and will apply if any services are rendered not expressly listed in either Section 2 or 3 of this Contact and may be done so verbally on the event date only. Payment of all additional fees are due at the completion of services rendered on the event date.

General Hourly Rate - \$50.00/Hour excluding materials cost.
Delay Rate - \$100.00/Hour as a result of client-related delays.
Travel Rate - \$1.00/Mile in excess of any travel to or from the Contract event location.
Parking at Contracted Event Location – Any fees relating to parking shall be paid in full by the client.

AVAILABILITY. If the Hair Stylist is unable to perform to the guidelines of this contract in the unlikely event of severe medical, natural or other emergency, every effort will be made to secure a replacement artist. If a suitable replacement is not found, responsibility and liability is limited to the return of all payments received, and the Hair Stylist shall have no further liability.

SATISFACTION GUARANTEE. Services will be completed to Client's satisfaction, but is not to exceed allotted contracted time. Ample time is given for each look upon booking. Acceptance of completed look by Client is acknowledgement by Client that makeup is done to his / her satisfaction.

MISCELLANEOUS. This Contract and the attached rider(s), if any, set forth the entire agreement between the parties may not be amended, altered, or modified except in writing and signed by both parties. This Contract will be governed by and construed in accordance with the laws of the State of California, without regard to the principles of conflicts of law. In any action or proceeding involving a dispute between the Client and the Artist arising out of this Contract, the prevailing party will be entitled to receive from the losing party reasonable attorney’s fees. If any provision or provisions of this Contract shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby. By signing this contract, the Client and Hair Stylist agree to all terms and conditions stated in this Contract and is not valid until signed by both parties.

SIGNATURES AND EXECUTION OF CONTRACT. Hair Stylist and Client have each caused this Service Contract to be signed by it duly authorized representative.
